#### **Statement for Publication**

PLUS efficiently and effectively organise and run a large number of summer schools spread out over the UK. The operation is seasonal with a dedicated year-round staff located at its Head Office in London.

The systems and procedures for setting up, staffing and administering the centres are robust and effective. Documentation relating to the running of the centres is comprehensive and entirely appropriate for the staff contracted to carry out the duties and responsibilities. Recruitment processes have been effective in securing generally well-qualified and experienced centre staff all of whom were committed to providing good service in a supportive manner.

The inspectors found that feedback from students, teachers and group leaders was highly positive in all areas with the exception of issues relating to food.

Classrooms and breakout spaces were of a good standard and in some cases excellent. Residential rooms were of a typical university standard and ranged in quality from acceptable to good. Some of the classrooms and offices in use by PLUS were spread out across campuses and it would be desirable to have these closer together to facilitate closer supervision of students.

The matter of inspection of homestay provision is pending and this will have to be focused on in any subsequent inspections.
