Windsor English continues to offer English language classes in a friendly environment and attracts a good mix of nationalities. Students and staff enjoy a strong sense of community and are quick to recommend the school to family and friends.

The school building is small, but well-maintained, and recent rebranding gives a positive impression. Resources are somewhat dated but investment in screens in classrooms and the use of cloud-based resource storage has been well-received by staff.

Administration and records are largely in place and information can be swiftly located and presented.

Retention of the teaching staff for a number of years is a testament to the environment and support provided to teachers. Teaching quality was considered to be adequate but the current teaching team could be developed to deliver to a very high standard.
