#### Statement for Publication

The North of England School of English has established itself as a high-quality local provider of English teaching specialising in teaching small groups and one to one lessons. Its students are prepared to travel a long way to come to class and often attend after a long day at work. Four years on from its foundation, it provides quality education to students who appreciate the progress they have made and are making with every lesson. The students spoke very highly of the standard of teaching at NESE but also made the point that all aspects of the school were very good. All the students spoken to during the inspection had recommended at least one friend to the school.

Classroom practice at NESE is very good. Teaching is currently delivered by a single individual who is seeking to improve as a teaching professional by taking the DELTA course.

Provision of junior courses is very limited at the moment and the circumstances of the students who have attended courses has meant that there has been a relatively minor pastoral role for NESE. However, any increase in the frequency of junior courses will lead to a need for consideration of how this pastoral responsibility is embedded into the welfare policy and delivered in practice. This report makes requirements of the school relating to the level of junior provision and homestay. Any significant increase in the number of students under 18 and/or those in homestay provision must be reported to ABLS and may result in either a follow up inspection of welfare standards or the date of the next scheduled full inspection being brought forward.

The move to provide homestay accommodation to students presents new opportunities for NESE and the school has shown that in reviewing its practices and procedures in relation to homestay it is able to respond to new situations by producing procedures and policies that meet the standard of ABLS requirements.

- 1 The placement testing of students is thorough and involves the consideration of all four skills as well as tests of grammar and vocabulary knowledge. The placement process also considers the aims and needs of individual students and this information is used to inform the planning of courses of study.
- 2 NESE has developed a well-organised collection of supplementary materials that are catalogued by level and topic. These can be used by teachers to supplement the course book.
- 3 The use of technology such as smartboards in classes is well thought through and is integrated into lessons purposefully.
